

Precautions Pertaining to BANDAI CARD GAMES Official Events

For Asia

Those who apply for and participate (hereafter "Participant/Participants") in Bandai Co., Ltd. (hereafter "The Company")'s officially sponsored BANDAI CARD GAMES trading card game tournaments and events (hereafter "Event/Events") are required to review and agree to the following precautions (hereafter "Precautions") prior to submitting any applications. The act of submitting an application constitutes tacit understanding and approval of these Precautions.

Additionally, Participants considered to be minors (under the age of 18) must have these Precautions reviewed and agreed to by a parent, guardian, or other legal representative prior to applying.

Conditions for Application

1. Participants must be registered BANDAI TCG+ members.
Note: Additionally, they will each be expected to have the smartphone registered to their personal BANDAI TCG+ account with them at all times.
2. Participants 12 years old and under must be accompanied by a legal guardian age 18 or older (multiple applicants 12 years old and under may be represented by a single legal guardian).
Participants between 13 and 18 years old can be accompanied by a guardian age 18 or older.
Participants 18 years or older cannot be accompanied in the venue.
3. Participants must bring proof of identification (see "**Acceptable Forms of ID**" below for further details).
Note: The Company and the manager or managers of participating venues will not be held responsible for any damages incurred by Participants unable to take part in Events due to incomplete or absent proof of identification, or The Company canceling or rescinding participation eligibility for any reason.

General Provisos

1. Participants are expected to understand and comply with all Tournament rules, tournament rules, regulations, etc. set by The Company for participating Events.
2. Participants are expected to comply with all instructions, precautions, etc. mandated by venue staff. Neither The Company nor venue management will be held responsible for any accidents or incidents that may occur as a result of disregarding staff instruction.
3. Participants with a cough, cold or flu-like symptoms, and/or a temperature of 37.5°C/100°F or higher are asked to abstain from participation in any public Events.
4. Entry into the venue on the day or days of Events may be restricted due to the heavy volume of foot traffic.
5. All items sold or otherwise distributed within the venue will be limited in quantity. Individual inquiries regarding the stock of goods cannot be addressed.
6. Participants are advised to inform the staff immediately should any personal items be lost or found.
7. Participants are responsible for their own personal items and valuables. Neither The Company nor venue management is to be held responsible for any loss, theft, or mishandling of such items.
8. Any Participants who fall ill or feel any onset of physical debilitation are advised to seek assistance from staff immediately.

9. Participants are expected to personally bear the cost of their own communications, travel & lodging, and travel to the venue, as well as any other expenses pertaining to these Events.
10. Contents of these Events are subject to change without notice. Please note that The Company and any involved venues reserve the right to postpone, suspend, or cancel Events due to natural disasters, unforeseen accidents, or other unavoidable circumstances. In these situations, The Company shall not bear responsibility for any expenses incurred by Participants affected by Event postponement, suspension, and/or cancellation.

Prohibited Conduct

11. Participants may *not* engage in any of the following actions or activities while participating in Events. If The Company determines that any Participant (including any accompanying individuals, for whom the Participant is deemed responsible) has engaged in any of the Prohibited Conduct listed below, or is even suspected of planning to engage in such Conduct, The Company reserves the right to revoke the Participant(et al.)'s participation eligibility without advance notice (including but not limited to the revocation of associated rights and privileges, such as the receipt of commemorative items, the staging of side events, and the sale of merchandise). The Company also reserves the right to expel anyone in violation of this Conduct from the venue, and to blacklist such individuals from participating in any future Events.
 - (1) Participating in Events through multiple accounts at once.
 - (2) Participating in Events through someone else's BANDAI TCG+ account.
 - (3) Registering false information on the BANDAI TCG+ account (including information that does not match what is shown on the Participant's proof of identification).
 - (4) Loitering in the venue or its environs late into the night or early in the morning, or otherwise disturbing the peace within the venue's immediate vicinity.
 - (5) Drinking alcohol or smoking within the venue. (Note: smoking may be permitted in designated smoking areas *only*, depending on the venue)
 - (6) Using cards not manufactured, sold, distributed, or otherwise tendered by The Company (including but not limited to reproductions, bootlegs, counterfeits, and fakes).
 - (7) Trading or selling cards during Events.
 - (8) Defying instructions or appeals deemed necessary for the smooth operation or progression of Events.
 - (9) Willfully obstructing or hindering the smooth operation or progression of Events.
 - (10) Slandering or defaming The Company and/or other Participants (including but not limited to judges, staff, and anyone else affiliated in any way with any Events).
 - (11) Acting in violation of the law and/or willfully defying any Precautions listed in this document.
 - (12) Acting in violation of public order and decency standards. and anything in violation of local and federal laws.
 - (13) Bringing into the venue anything The Company or venue staff deem inappropriate or dangerous (including but not limited to explosives, flammable materials, explicit or de facto weapons or anything that could be perceived as a weapon, and any other items prohibited by law).
 - (14) In addition to the above, any other Conduct that The Company reasonably deems inappropriate for Participants of Events.

Photography and Videography Waiver

12. By entering the event, you agree that BANDAI and its affiliates and subsidiaries (collectively, "BANDAI") may photograph, record, digitally enhance or recreate, and otherwise capture you, your name, likeness, and any audiovisual content containing or related to the foregoing (collectively, the "Footage") which may be used by BANDAI in any program, including without limitation in connection with the development, production, distribution, advertising, publicity, promotion and exploitation thereof in and all means and media, now known or hereafter devised and in all languages, throughout the Universe in perpetuity. In consideration of your appearance therein, and without any further consideration from BANDAI, BANDAI will own all copyrights and other rights in and to the Footage. You irrevocably grant and assign all rights to the Footage, including your appearance therein, any "droit moral" rights and/or other moral and similar rights, to BANDAI. To the extent you cannot, by law, assign those rights, your appearance therein shall be deemed a "work-made-for-hire. "

The rights granted herein include without limitation the right to edit, delete, dub and/or fictionalize the Footage as BANDAI sees fit.

You will not receive any payments for your appearance in the Footage. You will make no claims against BANDAI as a result of your appearance in the Footage and you waive any and all claims related to copyright, libel, defamation, moral rights, rights of privacy and/or damages and/or expenses. If you do not wish to appear in the Footage or under these conditions, do not enter this area.

13. General photography and videography are permitted within the venue. Permission needs to be granted from any persons being captured in content not related to BANDAI. No equipment can be used that impedes traffic or obstructs walkways.

Participation in Competitive Content

14. Individuals accompanying Participants (including parents and legal guardians) will not be permitted to enter the competition space or receive any commemorative items, including souvenirs for attendance.
15. Participation in competitive contents is limited to solo Participants, with exceptions made for those whom The Company deems necessary to provide aid to those Participants (potentially including parents or legal guardians), such as in the case of wheelchair-bound, chronically ill, injured, or otherwise incapacitated competitors.

BANDAI TCG+

Please read below regarding using BANDAI TCG+ to participate in tournaments.

16. Participants are expected to have the smartphone registered to their personal BANDAI TCG+ account with them at all times during Events.
17. If The Company suspects a Participant may have applied through multiple accounts, The Company reserves the right to cancel that Participant's application(s) and/or rescind participation eligibility without prior notice, also bear no responsibility to refund any expenses incurred by the Participant related to the Events.
18. Depending on Events, Participants may be requested to submit their applications through BANDAI TCG+. Application procedures for Events will be outlined on their official websites. Please ensure all

applications are submitted through each Participant's own BANDAI TCG+ account. Applications by proxy are prohibited. Other competitions will be held through BANDAI TCG+ as well, so Participants are advised to ensure all information submitted during the application process is accurate and up-to-date.

19. Participants' personal information (as seen when tendering proof of identification) may be checked against the information registered to that Participant's BANDAI TCG+ account at any time during Events. If any discrepancies are found during this check, participation eligibility may be revoked. Please exercise all due care and comply with these checks as requested. Note that revocation of participation eligibility may also entail the forfeiture of rights to the acquisition, participation, and/or sale of, in, or pertaining to commemorative items and/or attendance souvenirs, side events, merchandise sales, etc.
20. Please note that neither The Company nor its affiliates guarantee to be able to accommodate requests for changes to a Participant's application after it has been submitted. To prevent complications, please exercise all due care and attention during the application process.
21. If circumstances change and Events can no longer be attended after successful application, affected Participants are requested to please cancel their applications in advance via "Cancel Application" under My Events. If prospective Participants are on the waiting list for attendance of Events they can no longer attend, those individuals are also requested to please cancel their applications in advance via "Cancel Application" under My Events.
22. If Participants are selected to take part in Events but are not present at the onset of said Events and have not canceled their applications in advance, this will be deemed "unauthorized cancellation." If prospective Participants on the waiting list for attendance of Events are selected to take part in those Events but are not present at the onset of said Events and have not canceled their applications in advance, this too will be deemed "unauthorized cancellation."
23. In accordance with the BANDAI TCG+ Fair Play System, those Participants deemed responsible for unauthorized cancellation may be limited in or restricted from submitting applications for future Events.

24. All notifications pertaining to selection for participation in Events will take place through BANDAI TCG+.
25. Those who wish to register a BANDAI TCG+ account must first register a BANDAI NAMCO ID. As of February 2, 2023 (Thursday), "Family Groups" have been integrated into BANDAI NAMCO ID. Those using a under 13 child's BANDAI NAMCO ID account are requested to please review the contents of the link below before applying.

Acceptable Forms of ID

27. One of the following items proving the Participant's personal identification must be on hand to ensure participation eligibility for Events. Those who do not present any of these items upon request will be denied participation.

[Examples of valid IDs for each country/area]

- Hong Kong S.A.R.: Passport; Hong Kong Identity Card; Macau Resident Identity Card
- Indonesia: Passport; KTP; KIA
- Malaysia: Passport; MyKad; MyKid; Driver's License; Student Card; Employment Pass
- Philippines: Passport; PhilSys ID; PhilID (Philippines National ID); Driver's License; School ID
- Singapore: Passport; NRIC Card or App; Student Card; Student ID; Driver's License; Employment Pass
- Taiwan Area: Passport; R.O.C. National ID (中華民國國民國民身分證)
- Thailand: Passport; Thai Citizen ID Card; Driver's License; Non-immigrant VISA

If you plan to bring an ID not listed above to the event, please check with your local distributor in advance to confirm the validity of the ID
